This agreement is entered into by and between Event Sponsor and the Artist/Artisan filling out, electronically signing and submitting the online application (Artist). The Artist hereby agrees to indemnify and hold harmless the Event Sponsor, their agents, employees and volunteers from any and all claims, including costs and attorney's fees resulting there from said Artist's participation in the event which has been organized by or through the Event Sponsors.

For the purpose of this agreement, the term "participation" shall include, but not be limited to: the delivery of equipment, merchandise, structures and arts or crafts to their designated location; the set up and display of any such structures and arts and crafts; and the dismantling and removal of all such items from the area provided by or through the Event Sponsor or their agents and employees.

The Artist hereby expressly assumes any risk of harm to the Artist, works of art, guests, or guests' property arising out of their participation of other artists or agents in Queen of Arts hosted by the event sponsor, including any risk resulting from the location of the space designated for the Artist by the Event Sponsor. The Artist agrees to hold harmless the Event Sponsor from all liability for damages to persons or property from any source. If weather, other acts of Nature, or other reasons beyond the control of the Event Sponsor causes the event's cancellation, Artist entry fees will not be refunded.

This agreement shall be effective immediately upon execution and shall continue in effect through the event that the Artist participates in that is organized by the Event Sponsor.

The work described in the online Application is created by the Artist.

Artist acknowledges and agrees that all parties entering the Museum property consent to being recorded and/or photographed and agree that the Museum may use the likeness or voice for any lawful purpose including promotional, social, and advertising materials. Artist acknowledges and agrees that photographs submitted in the application may be used by the Event Sponsor for promotional, social, and advertising materials.
